Government Resolution: The Maharashtra Public Service Commission has recommended appointments for candidates to the post of Assistant Professor under the Maharashtra Education Service (College Branch), Group - A for reserved backlog vacancies. Among these, 37 candidates listed in Annexure "A" are being appointed, based on their nomination to the respective posts of Assistant Professor, Group - A, effective from the date of their actual joining, and on a purely temporary basis, subject to the following terms and conditions:

(One)

- (a) The pay scale for these officers will be Rs. 8000-275-13,500.
- (b) In addition to this pay scale, allowances such as Dearness Allowance, House Rent Allowance, and Local Compensatory Allowance will be permissible as determined by the government from time to time.
- (c) These officers will receive their first increment after completing one year of the probationary period, and further increments will be given upon the satisfactory completion of the probationary period.

(Two)

The appointment of these officers to the post of Assistant Professor, Maharashtra Education Service (College Branch), Group - A, will be on a probation period of two years from the date of appointment.

(Three)

These officers must accept the appointment within one month from the date of this Government Resolution. If the appointment is not accepted within the stipulated period, they will lose their seniority based on the merit obtained in the Commission's examination. Furthermore, if there is no response within the given time, their names will be removed from the selection list without any prior notice.

(Four)

It is mandatory for these officers to pass the Marathi and Hindi language exams if they have not already passed them or if they have not been exempted from passing them.

(Five)

As per the Government Resolution, General Administration Department No. Training-2000/Pr.Kr.61/2001/39, dated 7th August 2001, officers must submit a government-approved certificate of passing the prescribed computer handling/usage examination within six months from the date of this Government Resolution.

(Six)

Officers listed in Annexure-A are liable to have their service as Assistant Professor, Maharashtra Education Service (College Branch), Group - A terminated or reduced without any prior notice if:

- (a) Their performance during the probation period is not up to the expected standards.
- (b) Their conduct is found to be unsatisfactory or unbecoming of a Group-A officer.

(Seven)

As per Government Resolution, Finance Department No. Aniyo 1005/126/Service-4, dated 31st October 2005, officers appointed on or after 1st November 2005 will be covered under the New Defined Contribution Pension Scheme. The existing pension schemes (i.e., Maharashtra Civil Service (Pension) Rules, 1982 and Maharashtra Civil Service (Compulsory Annuity) Rules, 1984), as well as the General Provident Fund Scheme, will not be applicable.

(Eight)

No travel allowance will be provided to these officers to report at the place of appointment.

2. Candidates who are currently serving in Government/Semi-Government posts must submit a certificate of release from their previous post to the Director of Education, Higher Education, Maharashtra State, Pune, through their respective Principals.
3. Upon receiving these orders, all officers must report to their respective appointment locations and submit a report to the Director of Education, Higher Education, Pune, and the Government.
4. The notification regarding these appointments will be published in the Maharashtra Government Gazette in due course.
