Government Resolution:-

Maharashtra Public Service Commission Recommended the following candidates for the post of Assistant Professor, Marathi, Maharashtra Education Service Group 'A' (College Branch) in the organization indicated against their names for a probationary period of two years from the date on which they will assume charge of the post.

2. The above candidate is being appointed on the post of Assistant Professor, Marathi, Maharashtra Education Service Group-A (College Branch) by nomination, purely on a temporary basis subject to the following terms and conditions from the date of his physical appearance:-

1) The pay scale of the above candidates is Rs. 15600-39100 Grade pay will remain at 6000.

2) In addition to the above pay scale dearness allowance, house rent allowance and local supplementary allowance shall be admissible at such rate as may be decided by the Government from time to time.

3) The above candidates will be given first increment after completion of one year of probationary period and subsequent increment after satisfactory completion of probationary period.

4) If the work or conduct of the aforesaid candidates during the probationary period is found to be inappropriate, not up to standard or unsatisfactory, his service shall be liable to be terminated or reduced from service without any prior notice.

5) It will be mandatory for the above candidates to work as Hostel Superintendent (Rector / Warden) for at least 3 years (1 term).

6) Government Resolution, General Administration Department no. Under Training 2000/P.No.61/2001/39, dated 7/8/2000, knowledge of computer handling/usage has been specified as an essential qualification for recruitment in government services. The above candidates have passed the Government Resolution General Administration Department no. Training 2000/P.No.61/2001/39, dt. 19/3/2003 required certificate to be provided within two years from the date of appointment order. If he does not provide the certificate within the prescribed period, his services in the said post will be terminated without any prior notice on the expiry of the said period.

7) Appointment of the above candidate subject to the rules prescribed for direct entry to service, unless they have previously passed the examination in Hindi and Marathi language or have not been exempted from passing the said examination, they must pass the said examination within the prescribed time. If not, their pay increment will be withheld.

8) The appointment of the above candidates is purely temporary and if it is directed that their character and previous character verification report is unsatisfactory, their appointment will be terminated by giving one month's notice without assigning any reason.

9) Appointment of said candidates Hon. Tribunal, Mumbai Original Application No. 781/2013 filed in the Tribunal, Mumbai is being made subject to the final judgment of the Court.

10) Under Rule 11 (1) of the Maharashtra Civil Services (General Conditions of Service) Rules, 1981, the above candidates shall be required to submit a medical certificate of health before completion of six months of service from the date of appointment.

11) The pay of the above candidate will be fixed as per the provisions of the Maharashtra Civil Services (Pay) Rules, 1981.

12) Candidates mentioned in paragraph-1 should immediately join the post indicated against their name within one month from the date of the order. If they do not accept

the appointment within the said prescribed period, then they obtained in the examination conducted by the Commission. They will not get the seniority admissible in order of merit. Moreover, if he does not report anything within the above term regarding the present appointment, his name, the said order of his appointment will be cancelled without any prior notice.

13) Government Circular, Finance Department, no. According to the provisions of Annio-1009/Pro.No.32/Seva-4, dated 18/8/2009, Government employees who were working in the Government Service Pension Establishment prior to November 1, 2005, for appointment to the post of Pension Establishment in the same or other department. If he has applied before or after 1st November, 2005 and has been appointed to the new post on or after 1st November, 2005, in such case Government Circular, Finance Department, No: Annio- 1006/87/Seva-4, dt. Maharashtra Civil Services (Pension), Rules, 1982 and General Provident Fund Scheme will apply to the Government servant concerned if all the conditions mentioned in (1) to (iv) of 12th January, 2007 are fulfilled. d. Newly Defined Ashdan Pension Scheme will be applicable to Government employees in case all the conditions (1) to (iv) mentioned in circular dated 18/8/2009 are not fulfilled.

14) Retirement age of the above candidates as per prevailing rules Government Decision no. 2010/(503/10) vide 1, dated 05.03.2011 shall remain 62 subject to the conditions prescribed.

15) No travelling allowance will be given to the above candidates for attending the place of appointment

16) The above candidates are required to give one month's notice to the government or pay one month's salary before leaving the job.

3. As soon as this order is received, the concerned candidates should appear at the place of appointment and submit the report to the head of the concerned institution. The head of the institution should submit a report in this regard to the government through the director

4. The notification regarding the appointment of the said candidates will be published in the Maharashtra Government Gazette as soon as possible.
