Regarding regularization of services of temporary / contract lecturers / librarians / directors physical education in government colleges/institutions under Directorate of Higher Education.

Background:-

Teaching posts in Government Colleges/Institutions under the Directorate of Higher Education under the jurisdiction of the Department of Higher and Technical Education come under the purview of the Maharashtra Public Service Commission. However, due to the procedure prescribed by the commission for filling the posts and the time required to appoint the candidates awarded by the commission through the said procedure, there is a delay in filling up the teaching vacancies in the government colleges. Therefore, to avoid the educational loss of students due to lack of sufficient number of teachers, Government Decision No. SCT-1092/1740(316/93) Mashi-2 dt. 29/1/1994 as well as Government Decision no. Meeting-1002/ (91/2002)/Astha-1 dt. On 25/7/2002, a selection committee and procedure for appointment of teachers on seasonal and contractual basis was constituted on a temporary basis.

When the services of temporary and contractual lecturers/librarians/directors of physical education appointed through the said selection committee were terminated after the prescribed period, the said lecturers/librarians/directors of physical education were appointed by Hon. High Court / Hon. Interim protection was obtained by the temporary service through the Maharashtra Administrative Tribunal. Therefore, their temporary and seasonal services had to be continued for a long time. Meanwhile, the said employees demanded regularization of their services. High Court/Hon. Through various petitions / original applications before the Bench of Maharashtra Administrative Tribunal. Of these Hon. Petition filed in High Court, Bench, Nagpur no. 526/2015 and petition no. 850/2015 dated By order dated 3/9/2015 as well as Hon. Original application filed in Maharashtra Administrative Tribunal, Mumbai no. 781/2013. 868/2014 and 150/2015 dt. As per order dated 26/6/2015 Hon. High Court, Bombay Bench Nagpur in Petition no. Dated in 2046/2010. Ordered to regularize the services of the petitioners/applicants as per the decision dated 19.10.2013.

Petition no. 2046/2010 is related to the regularization of the services of contractual lecturers appointed on contract basis in Government Technical College. High Court, Bombay Bench Nagpur. On 19.10.2013, after passing judgment on the said petition, it was directed to regularize the services of the petitioners. Against the said orders, Hon. Special Leave Petition No. 39014/2013 filed in the Supreme Court Hon. Supreme Court, New Delhi. Dissolved on 06/01/2015 Hon. High Court, Nagpur Bench D. Order dated 19/10/2013 upheld. Thus petition no. 2046/2010 of Hon. High Court, Bombay Bench Nagpur. The order dated 19.10.2013 has been finalised.

Petition no. 526/2015 and petition no. 850/2015 as well as original application no. The judgments in 781/2013, 868/2014 and 150/2015 are as follows:-

1) Petition no. 526/2015 and 850/2015 :-

"The respondent are directed to regularize the services of the petitioners and confer permanency. The respondents are directed to absorb the petitioners in service within a period of six week, on parity with the petitioners in Writ Petition No. २०४६/२०१०. Since the petitioners are in continuous employment, the petitioners should be continued in service as the regular employees. We direct the respondents to pay the regular salary to the petitioners from २.०९.२०१५. Though the petitioners would be entitled to continuity in service, the said continuity would be for purposes other than monetary purposes

2) Original application no. 781/2013, 868/2014 and 150/2015:-

"The respondents are hereby directed to regularize the services of the Applicants Nos. It to I and I to I in O.A. No. 668/1908 and the Applicants in O.A. 840/1908 and 656/1908 and confer permanency to them. The Respondents shall absorb the Applicants just referred to by 38st July, 2004 and the said Applicants will continue in service as regular employees. However, in the facts and circumstances of the case, we direct that the Applicants shall be entitled to regular salary from 8st August, 2004 and would not be entitled to claim any monetary benefits for the past services rendered by them in spite of their regularization. Needless to state that since the above referred Applicants' services are regularized, they shall be entitled to the continuity and service for all other purposes except monetary purposes from the date of their first appointment. The government may take an appropriate decision about the scheme of pension applicable to the Applicants."

As above petition no. 526/2015 and petition no. 850/2015. Also original application no. Decisions given in 781/2013, 868/2014 and 150/2015 and Hon. High Court, Bombay Bench Nagpur in Potition no. Dated in 2046/2010. Possible vide decision dated 11.10.2013

Considering the legal proceedings and the final decision therein, the implementation of the above decisions has been ordered.

Petition no. In 2046/2010 Hon. Taking into consideration the directions given by the High Court, the temporary contract lecturers/librarians/directors of physical education working in the colleges/institutions under the Directorate of Higher Education have been examined accordingly and the decision has been taken to regularize the services of 42 temporary contract lecturers/librarians/directors of physical education who are qualified accordingly. It has been taken in the Cabinet meeting held on 17/12/2015.

Government Decision :-

The services of 42 Contractual/Seasonal Assistant Professors/Librarians/Directors of Physical Education working in Government Colleges/Institutions under the Directorate of Higher Education and included in the attached prospectus are being regularized subject to the following conditions:-

- 1) The services of Hagami "Contract Assistant Professor / Librarian / Director of Physical Education in the accompanying prospectus are being regularized from the date shown in the prospectus.
- Regularized Assistant Professor / Librarian / Director of Physical Education are being granted all service benefits from the date of regularization of their services.
- 3) No monetary benefits shall be admissible to the concerned Assistant Professor / Librarian / Director of Physical Education due to termination of service in respect of the service rendered by them during the previous service period.
- 4) This temporary / contract lecturer //librarian / director of physical education Hon. The regular pay and allowances admissible under the rules shall continue to be payable as per the order of the court and from the date shown against his name.
- 5) The action taken regarding the regularization of the services of the said teachers will not be retrospective in future.
- 6) The pension scheme prevailing on the date of regularization of service to Assistant Professors/Librarians/Directors of Physical Education who have regularized their services will continue to be applicable.
- 7) Medical examination at the time of appointment in government service by direct service. Character Verification Report, Knowledge of Computer Manipulation (MSCIT) as well as Marathi and Hindi Language Test Passing are all Government Orders to Assistant Professors/Librarians/Directors of Physical Education who have regularized these services, will remain applicable.
- 8) Among regularized Assistant Professors/Librarians/Directors of Physical Education, those candidates belonging to Backward Classes shall be appointed within 6 months.

 Caste validity certificate will be required to be submitted.)

9Probation period will not be applicable to said 42 teachers.

10) Regarding the regularization of the services of the teachers at 27 serial number 5 of the report of Savat, Mr. Against the order given by the Administrative Tribunal, the Government Hon. high

11) The services of teachers mentioned at Serial Nos. 28 to 42 in the accompanying prospectus, Govt. Appeal Petition No. filed in the High Court, Bombay. 8708/2015 subject to final decision as well as Hon. Pending in Maharashtra Administrative Tribunal, Mumbai Original Application No. 558/2015. 705/2015. 161/2015, 531/2015. 429/2015, 602/2015 subject to the final decision received, regularization is approved.
