Government Decision:-

Sponsored by the Maharashtra Public Service Commission, the following candidate is being appointed on deputation to the post of Assistant Professor, English, Maharashtra Education Service Group 'A' (College Branch) in the organization indicated against his name for a probationary period of two years from the date on which he will assume charge of the post.

2. The above candidates are being appointed to the post of Assistant Professor, English, Maharashtra Education Service Group-A (College Branch) by nomination, purely on a temporary basis from the date of their physical appearance subject to the following terms and conditions:-

1) The pay scale of the above candidates is Rs. 15600 - 39100 category salary will remain at 6000. 2) In addition to the above pay scale dearness allowance, house rent allowance and local supplementary allowance shall be admissible at such rate as may be decided by the Government from time to time.

- 3) The above candidates will be given first increment after completion of one year of probationary period and subsequent increment after satisfactory completion of probationary period.
- 4) If the work or conduct of the aforesaid candidates during the probationary period is found to be improper, below standard or unsatisfactory, their service shall be liable to be terminated or reduced from service without any prior notice.
- 5) It will be mandatory for the above candidates to work as Hostel Superintendent (Rector / Warden) for at least 3 years (1 term).
- 6) Government Decision, General Administration Department no. Training 2000/P.No.61/2001/39, dated 7/8/2000 has specified knowledge of computer handling/usage as an essential qualification for recruitment in government services. The above candidate has passed the Government Decision General Administration Department no. Required certificate under Training 2000/P.No.61/2001/39,dt.19/3/2003 must be provided within two years from the date of appointment order. If they fail to provide the certificate within the prescribed period, their services on the said post will be terminated without any prior notice on the expiry of the said period.
- 7) The appointment of the above candidates shall be subject to the rules prescribed for direct entry recruitment unless they have previously passed the examination in Hindi and Marathi language or have not been exempted from passing the said examination within the prescribed time limit. If not, their pay increment will be withheld.
- 8) Appointment of said candidates Hon. Original Application No. 781/2013 filed in the Tribunal, Mumbai is being disposed of subject to the final judgment of the Court.
- 9) The appointment of the above candidates is purely temporary and if it is directed that their character and previous character verification report is unsatisfactory, their The appointment shall be terminated by giving one month's notice without assigning any reason. 10) The aforesaid candidate shall be bound to submit a medical certificate of health before completion of six months of service from the date of appointment under Rule 11 (1) of the Maharashtra Civil Services (General Conditions of Service) Rules, 1981.
- 11) The pay of the above candidates will be fixed as per the provisions of the Maharashtra Civil Services (Pay) Rules, 1981.
- 12) Candidates mentioned in paragraph-1 should immediately join the post indicated against their name within one month from the date of the order. If they do not accept the appointment within the said prescribed period, they will not get the seniority admissible according to the order of merit obtained by them in the examination conducted by the Commission. Moreover, if they do not report anything within the above term regarding the said appointment, their name, the said order of their appointment will be canceled without any prior notice.
- 13) Government Circular, Finance Department, no. According to the provision of Annio-1009/P.No.32/Seva-4, dated 18/8/2009, the Government employee who was working in the Government Service Pension Establishment prior to November 1, 2005, for appointment to the post of the Pension Establishment in the same or other department, dt. has applied on or after 1st November, 2005 and has been appointed to the new post on or after 1st November, 2005

In such a case, if all the conditions mentioned in (1) to (iv) of the Government Circular, Finance Department,

No: Annio-1006/87/Seva-4, dated January 12, 2007 are fulfilled, the concerned Government servant will be entitled to Maharashtra Civil Service (Pension)), Rules, 1982 and the General Provident Fund Scheme will be applicable. d. The new defined contribution pension scheme will be applicable to the Government employees in case all the conditions (1) to (iv) mentioned in the circular dated 18/8/2009 are not fulfilled.

- 14) Retirement age of the above candidates as per prevailing rules Government Decision no. 2010/(503/10) vide 1, dated 05.03.2011 shall remain 62 subject to the conditions prescribed.
- 15) The above candidates will not be given traveling allowance to attend the place of appointment.
- 16) The above candidates are required to give one month's notice to the government or pay one month's salary before leaving the job.
- As soon as this order is received, the concerned candidates should appear at the place of appointment and submit the report to the head of the concerned institution. The head of the institution should submit a report in this
