Government Decision:- Maharashtra Public Service Commission has recommended 4 candidates for appointment to the unreserved post of Assistant Lecturer, Geography in Maharashtra College Education Service Group-A. As mentioned in the table below; the Advocates indicated against the names of the candidates are being appointed on a purely temporary basis subject to the following terms and conditions, from the date of their physical appearance on the post of Group-A.

(a) (a) The pay scale of these officers shall be Rs.8000-275-13,500.

(b) Dearness allowance, house rent allowance and local supplementary allowance shall be admissible at such rate as may be decided by the Government from time to time in addition to this pay scale.

- (c) The first increment shall be given to these officers after completion of one year of probationary period and Subsequent increments will be available after satisfactory completion of the probationary
- (Two) period. Appointment of these officers to the post of Maharashtra College Education Service Group-A, appointment will remain on Probation for a period of two years from date.
- (iii) It is mandatory for these officers to accept appointment within one month from the date of this Government Decision.

 If they do not accept the appointment within the said prescribed period, they will not get the seniority admissible according to the order of merit obtained by them in the examination conducted by the Commission. Also, if they do not inform about the said appointment within the above deadline, their name will be removed from the selection list without any prior notice.
- (iv) It shall be compulsory for these officers to pass the Marathi and Hindi Language Examination, if they have not already passed that examination or have not been exempted from passing the examination.
- (5) These officers have passed the Government Decision, General Administration Department no. According to the provision of Training-2000/P.No.61/2001/39, dated 7th August, 2001, the government approved certificate of passing the examination prescribed in computer handling/use will be required to be submitted within six months from the date of this government decision.

- (vii) The officers mentioned in the above prospectus shall be entitled to termination of service or reduction from service in the Maharashtra College Education Service, Group-A post without prior notice:

 (a) whose work during the probationary period was/is not found to be of the expected standard.
 - (b) whose conduct is/would not be found unsatisfactory or unbecoming of a Group-A officer.
- (seven) to the officers mentioned in the said prospectus Government Decision Finance Department no. As per Annio 1005/126/Seva-4, dated 31st October, 2005, "the new 'Defined Contribution Pension Scheme' shall apply to them on or after 1st November, 2005. The Maharashtra Civil Services (Retirement Pay) Rules, 1982 and the Maharashtra Civil Services (Gratification of Retirement Pay) Rules, 1984) and the existing General Provident Fund Scheme shall not apply."
- (8) These officers will not be given traveling allowance for attending the place of appointment.
